

# **GCA Board Meeting Minutes**

## Call to Order

The meeting of the Georgia Chess Association board was held on May 16, 2017 at the food court in the Cobb Galleria. The meeting was called to order at 7:14 PM.

### **Approval of Minutes**

Minutes from previous meeting were approved with minor changes.

#### **New Business**

- New board members Thad Rogers and Parnell Watkins are welcomed to the board.
- Board discusses selection of 2<sup>nd</sup> Vice President. Dave Hater is the only candidate who expressed an interest in this position. No other names were proposed.

- Susan Justice encourages new board to address logistical issues, namely the issue of storing equipment and the lack of shelving. Informs board that Tricia Hill has agreed to organize QuickStart, and Katie Hartley has agreed to organize MLK tournament.
  - Motion is made that Tricia Hill (Quick Start), Katie Hartley and Susan Justice (MLK 2018), and Ted Wieber (High School) be made coordinators for their respective events.
  - Motion is seconded.
  - Motion carries.
- Motion is made to allocate \$1,000 to be spent on shelving for GCA equipment storage.
  - Motion is seconded.
  - Motion carries.
- Board discusses whether or not to hold Qualifier at the Infinite Energy Center as opposed to the Cobb Galleria.
- Motion is made to secure a contract from Infinite Energy Center
  - Motion passes
